Dear Brothers and Sisters:

OFFICIAL NOTICE – NOMINATIONS AND ELECTIONS

LOCAL UNION 20, IBEW

In accordance with Article III, Section 9 of the Local Union Bylaws, nominations for officers of IBEW Local Union 20 will be held on **May 5, 2009** beginning at 7:00 PM at the local union meeting at the Electrical Training Center, 680 W. Tarrant Rd., Grand Prairie, Texas 75050. Anyone desiring to be nominated must be present during the nominations or provide a written and signed statement that they will accept the nomination. No member may be a candidate for more than one (1) office. Anyone nominated to more than one office must choose the office for which they will be a candidate.

Nominations will proceed in the order of offices as listed in the IBEW Constitution whose term of office shall be three (3) years:

President/Delegate to the International Convention
Vice President
Recording Secretary
Financial Secretary/Business Manager/Delegate to the International Convention
Treasurer
Executive Board (7 members)
Examining Board (5 members)
Delegate to the International Convention (5 members in addition to the B.M. & Pres.)

In accordance with Article VIII, Section 3, the Business Manager and President shall, by virtue of their offices, serve as delegates to the International Convention.

At this time, Local Union 20 is entitled to seven (7) delegates to the International Convention to be held in September, 2011. The election of delegates to be in accordance with Article II of the IBEW Constitution and Article VIII, Section 2 of the Local Union Bylaws. Local Union past practice is that nominees not elected as delegates become alternates based upon number of votes received.

In order to be nominated for an office or as a delegate to the International Convention, a member must have a minimum of two (2) years of continuous good standing in Local Union 20. Good standing means that the member is current in the payment of dues and has been for the two (2) years preceding the nominations.

In accordance with IBEW Constitution, Article XV, Section 14, no apprentice shall be eligible to hold any office in the L.U., except that a member who was previously eligible to hold office in the L.U. shall remain eligible if he entered an apprenticeship program for the purpose of upgrading his classification.

All nominations are in accordance with Article II, Article XV, and Article XVI of the IBEW Constitution and Article III of the Local Union Bylaws.

The election shall be conducted by mail ballot, and ballots shall be counted beginning at 8:00 AM on June 4, 2009 at the Electrical Training Center. All members in good standing shall be mailed a ballot not less than fifteen (15) days prior to the above-specified date. Ballots received after the close of business on June 3, 2009 will not be counted. Instructions on the use of the mail ballot will be enclosed with the ballot.

In the event a runoff election is necessary, it shall also be conducted by mail ballot twenty one (21) days after the election. Ballots shall be counted beginning at 8:00 AM on June 25, 2009 at the Electrical Training Center. Ballots received after the close of business on June 24, 2009 will not be counted.

Any member who does not receive a ballot by mail may make a written request to the IBEW Local Union 20 Election Judge and postmarked no later than Thursday, May 28, 2009.

Each candidate is permitted to have an observer at the pickup of the ballots and their delivery to the counting site, and to watch the entire proceedings. Observers may not interfere with the orderly procedure of the election.

All officers shall be installed and begin their three (3) year terms at the regular meeting of the local union on Tuesday, July 7, 2009.

Any member who believes a protest of the election is warranted during the conduct of the election is urged to contact the Election Judge. Further protests of the election may be filed in writing with the International Vice President of the district within thirty (30) days following the election. The decision of the International Vice President shall conclude the processing of a protest within the IBEW. In the event the protesting member is not satisfied with the decision of the International Vice President, the member may submit his/her protest to the U.S. Department of Labor.

REPRESENTATION ELECTIONS: On March 26, 2009 the National Labor Relations Board (NLRB) conducted a representation election for Hargrove Electric. Our IBEW members showed up in strength and voted 49 to 1 FOR THE UNION.

We also had another Representation Election on the same day for the employees of Stanley Works who make and install personnel entrance doors. There are 12 workers at Stanley Works and they voted 8 to 4 FOR THE UNION.

When constituents speak, Congress listens. Sending an original, handwritten letter and making a personal phone call are two of the most effective things you can do to be heard by your members of Congress. Following are some sample messages you can use as a guide in writing and calling your U.S. senators and representative. *Including your own thoughts and adding a personal story makes your correspondence more effective.*

Please model your personal message based on the points below when writing a letter to your U.S. senators and representative. Urge them to co-sponsor and support the Employee Free Choice Act (H.R. 1409 / S. 560).

- Please co-sponsor and vote for the Employee Free Choice Act.
