Dear Brothers and Sisters:

The national elections are rapidly approaching. Be sure that you and your family members are registered to vote. The deadline for registering is October 6, 2008. This election is an opportunity to elect candidates who may be labor friendly. Educate yourself on the issues. There is one candidate who is wanting to TAX YOU ON THE COST OF YOUR GROUP HEALTH INSURANCE.

All participants must be employed by an Employer that is signatory to an Inside Collective Bargaining Agreement with Local Union 20, IBEW or a member in good standing of Local Union 20, IBEW.

If this class fills up, and there is enough interest, we will try to schedule another class at a later date.

We have had some unfilled job calls nearly every day for the last 2 months. It has ranged from 2 - 25 unfilled calls covering numerous jobs and various employers. If you know of anyone in the non-union sector, please refer them to one of the Organizers or the LU Office.

The Trustees of the Health Insurance will increase the contribution rate from \$4.50 per hour to \$4.70 per hour effective Sep. 1, 2008. The twenty cent increase will be split equally between labor & employers in accordance with the labor agreement. Wages will be reduced by 10 cents per hour effective Sep. 1, 2008 to accommodate this change. Also, the PPO will change to Blue Cross of Illinois effective Dec. 1, 2008.

The Local Union office of Vice President is currently vacant. Please let me know if you might be interested in this office. The Executive Board will interview applicants and make an appointment. Please contact me if you have any questions.

### LABOR DAY HOLIDAY

The Local Union No. 20 Business Office will be closed on Monday, September 1, 2008 in observance of Labor Day. Business will resume on Tuesday, September 2, 2008.

**Below are the proposed Bylaws change which will have its second reading and be voted on at the next September 2, 2008 Union Meeting.**

**PROPOSED BYLAWS CHANGE**

**ARTICLE XII**

**Death Benefit Fund**

**Section 1.** There is hereby established in Local Union 20 a Death Benefit Fund for the payment of death benefits as provided for in this article.

**Section 2.** The provisions of this article shall apply to all "A" members of this Local Union who are members of the IBEW Pension Benefit Fund and former members on pension withdrawal with five (5) or more years continuous good standing in this Local Union immediately prior to retirement provided such retirement member elects to continue to participate in this plan and does so by paying death benefit assessments when due.

The above mentioned members or former members are hereinafter referred to as participants.

**Section 3.** All participating members shall pay \$6.00 into this Fund upon admission to membership in this Local Union.

**Section 4.** Upon the death of a participant who has been a participant for at least twelve (12) months immediately prior to his death, each participant shall be assessed \$3.00 if the balance in the Death Benefit fund is less than \$30,000. Assessments shall be due and payable within thirty (30) days after the date of the death of a participant and all monies collected from this assessment shall be deposited in the Death Benefit Account.

**Section 5.** "A" members in good standing in this Local Union and former members on pension withdrawal who have participated in this plan for one (1) year immediately prior to death shall be eligible for a Death Benefit equal to \$3.00 times the number of remaining members or \$5,000, whichever is lesser, to be paid in the following manner.

(a) If the participant is indebted to this Local Union, such indebtedness shall be deducted from the Death Benefit.

(b) After deduction of the indebtedness of the deceased, if any, the balance remaining, if any, shall be paid to the beneficiary or beneficiaries designated by the participating member in the IBEW Pension Benefit Fund.

**Section 6.** In the cases where the deceased has no beneficiary designated, the Executive Board of the Local Union shall authorize payment of an amount equal to the benefit payment toward the burial expenses of the deceased member, and if the entire benefit payment is not needed for this purpose, the balance shall remain in the Death Benefit fund.

**Section 7.** Anyone in arrears of death benefits more than one (1) year is considered a non-participant and will not be eligible to receive benefits from this fund.

**Section 8.** Claims on this fund shall only be paid in the amount the Fund is able to satisfy the claims and the participating members shall not be liable for any amount over and above the assessments set forth in this Fund.

**Section 9.** Under no circumstances shall any money from any other fund of the Local Union be transferred or used to supplement this Fund.

**Section 10.** The Death Benefit Fund shall be audited in the same manner and at such time as other funds of the Local Union are audited.

**Section 11.** This Fund is not maintained under a written trust.

**DUES INCREASE**

The Delegates of the 37th IBEW International Convention, which was conducted in Cleveland, Ohio during the week of September 11—15, 2006, approved amendments to Article IX of the IBEW Constitution. Effective January 1, 2009, there will be a per capita increase of one dollar (\$1.00) for all members, and the following rates will apply to the I.O. portion of all monthly dues payments covering January, 2009 through December, 2009.

In accordance with Article IX of the IBEW Constitution, \$12.00 per month from each member shall go into the General Fund, and the additional amount paid by “A” members (\$13.00 per month) will be deposited into the IBEW Pension Benefit Fund.
