HEALTH INSURANCE

If you have a health insurance claim that you feel should be paid at the in-network rate and should be appealed to the Trustees of the Insurance Fund, please contact me with the details. I can help with that process. We have a member who was involved in a motorcycle wreck on his way to work one morning and he was taken by ambulance to a hospital that was not in-network. Our insurance was going to pay out-of-network. His was an emergency situation and he did not have any control over which hospital they took him to. Karsten Frentrup and I visited him and his wife at the hospital and informed him of the correct appeal procedure. I attended the H&W Trustees meeting when his case came up and spoke on his behalf. The Trustees approved the payment as in-network.

I know of two (2) more cases coming up soon that have some special circumstances also.
