## A Message from A. C. McAfee Business Manager/Financial Secretary

### Dear Brothers and Sisters:

The Dallas Northaven Rd. property HAS BEEN SOLD! The closing of the deal was completed during the afternoon of Tuesday, July 8, 2008 and the money IS IN THE BANK! We have to be completely out of the building within 30 days, but we are 99.9% out now.

At a Special Called Meeting of the Building Committee on Tuesday, July 8, 2008, the members approved the purchase of 5.384 acres of land from the JATC and the construction of a new building for a new Union Hall for Local Union 20. I will attempt to keep the members updated as significant progress is made. My estimate is that it will take about 14 months to complete construction.

At the last General Membership meeting I informed the members that the Executive Board was considering a change to the referral procedure. After listening to the concerns of the members present, the Board has decided to leave the referral procedure as it is for now.

The General Election for President of the United States and other offices is rapidly approaching. I want to urge each member to make sure you are registered to vote. Also make sure that your family members are registered. Please take the time to educate yourself on the issues. Do not just believe all of the rumors that are already circulating.

If you have not signed a COPE deduction card to contribute a nickel an hour (\$2.00 per week) please do so. The COPE deduction goes into a fund which we can request money back for selected candidates. Sometimes a small contribution can go a long way towards helping a friendly candidate be elected. If you do not have access to a deduction card they can be picked up at the LU office or at the General Membership meeting.
