### IBEW-NECA SOUTHWESTERN HEALTH AND BENEFIT FUND

The Southwestern Health Trustees, at their meeting on April 15, 2009, made several decisions that affect our insurance. The five month hour bank was maintained. Health Reimbursement Accounts (HRA) requests no longer need to include an official SWHB Explanation of Benefits (EOB) form. The 65% federal subsidy on COBRA premium payments will be issued to qualified participants with their June payments. If you have exhausted your hour bank and are or will be utilizing COBRA to maintain your coverage, call the Benefit Office at 972-980-1123 to see if you qualify for federal subsidy money. I have asked the Trustees to adopt a method that will allow a member who is working in another jurisdiction that contributes more than our contribution rate to have the “overage amount” to be credited to their HRA. The money would follow the man and he would be credited with the entire amount of the contribution. The Trustees have taken this proposal under advisement, are doing some research, and will report at the next meeting on July 15, 2009.

**BONDED LIGHTNING**

A few weeks ago we completed negotiations of a new agreement with Bonded Lightning. This agreement is not just for Local Union 20, but is also for Oklahoma City, New Orleans, Austin, San Antonio, Houston, and Mobile, AL. All of the negotiating is done by Local 20. As a result of this contract, we were able to organize 60 new members into the IBEW.
